This certificate of Registration is awarded to **PAAVAI FOUNDATION INTEGRATED GIRLS CHILDREN HOME**, 55, Kaliyamman Kovil Street, TRICHY, Tiruchirappalli East Taluk, Tiruchirappalli District - 620004 as an institution for children in need of care and protection vide **1895/DSD/JJR/TIR/2026**. This institution is sanctioned to accommodate a total of **25 children (0 boys and 25 girls)** across 0 units under 50 capacity and 0 under 25 capacity, in accordance with Section 41(1) of the Juvenile Justice (Care and Protection of Children) Act, 2015.

This certificate of registration is valid from 08/05/2026 to 08/05/2031 (5 years) and is subject to the following conditions:

- 1.** The Management should run the Institution in accordance with Juvenile Justice (Care and Protection of Children) Act, 2015.
- 2.** Based on the infrastructure available at present, the institution shall **admit a maximum of 25 (Boys - 0) (Girls - 25) children** only.
- 3.** The Management of the Child Care Institution shall ensure that the sanctioned staff strength is consistently maintained, with a minimum of **12** personnel for an institution of **25** children as prescribed under the Tamilnadu Juvenile Justice Rules, 2017.
- 4.** This certificate should be displayed prominently for the information of parents/general public in the office room.

5. The following words may be mentioned in the name board of the Institution **PAAVAI FOUNDATION INTEGRATED GIRLS CHILDREN HOME, 55, Kaliyamman Kovil Street, TRICHY, Tiruchirappalli East Taluk, Tiruchirappalli District - 620004** is registered by the State Government under Juvenile Justice (Care and Protection of Children) Act 2015.

6. The services to the children shall be provided by the institutions registered under the Act as per section 53 of Juvenile Justice (Care and Protection of Children) Act, 2015.

7. The institution shall have a Management Committee in accordance with these Rules to manage the institution and monitor the progress of every child.

8. Institution should follow rules / regulations issued by State Government / Director/Commissioner of Social Defence from time to time.

9. The Institution is subject to inspection by the inspection authorities under the Act and by the persons / officers authorized by the State Government / Director/Commissioner of Children Welfare and Special Services / State Child Protection Society / District Child Protection Unit / Child Welfare Committee.

10. Orders should be obtained from Child Welfare Committees for all admissions and discharge.

11. Any admission / death / repatriation of the children in the institution and any discharge of children from the institution should be intimated to the concerned District Child Protection Officer and Child Welfare Committee in accordance with Tamil Nadu Juvenile Justice (Care and Protection of Children) Rules, 2017.

12. The registration certificate is valid for the period mentioned therein and is subject to the condition that all the required certificates / NOC are renewed in time before expiry and a copy has to be furnished to the District Child Protection Officer of concerned District and to the Directorate of Children Welfare and Special Services.

13. The Institution should provide proper infrastructure facilities including sufficient accommodation, health, toilet, and bathroom facilities and ensure safe drinking water, sanitation. The kitchen should be kept hygienic with a daily menu chart followed to ensure both quality and quantity in diet. Recreation and motivational activities should be arranged for children. Fire safety and rainwater harvesting facilities must be installed and the premises should not contain any thatched structures. Adequate firefighting equipment shall be provided and staffs shall be properly trained.

14. To ensure proper education, child rights and necessary safeguards from child abuses.

15. Closed Circuit Television cameras may be installed at all key points such as all entry and exit points to the Child Care Institution, reception, corridors, kitchen, pantry or store room, dormitories, entry and exit points of the washrooms with due regard to the privacy and dignity of the children.

16. The recognition/permission granted to the institution shall be deemed to be withdrawn in the event of violation of any of the above conditions by the institution.

The registration shall be subjected to the conditions laid down in the Juvenile Justice (Care and Protection of Children) Act, 2015 and the Rules made thereunder. The institution should comply with Rules / Regulations / Instructions issued by the State Government / Director of Children Welfare and Special Services from time to time.
